

THE CHANDON POP-UP HOSTED BY RIDGEWAY GROUP COMPETITION TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is AMP Capital Shopping Centres Pty Limited (ABN 13 001 595 955) of 33 Alfred Street, Sydney NSW 2000 AUSTRALIA telephone 07 5581 5118 ("**Promoter**").
3. Promotion entrants are required to be 18 years and older. The Promotion is not open to entrants under the age of 18 due to liquor licence laws.
